- IPS - 100% of SGST Collected
- Power Subsidy - 0.50 Paise per unit
- Interest Subsidy - 5% of Term Loan
- Electricity duty Exemption - up to 10 years
- Stamp Duty Exemption - On Land Purchase / Term Loan
